Uisce Éireann has reviewed your enquiry in relation to building near/under multiple Uisce Éireann assets, along the proposed route of the Cahermurphy West Windfarm Underground Cable Connection to Moneypoint, Killimer, Co. Clare. Based upon the drawings and crossings table you have provided, listed in Appendix 1, and as assessed by Uisce Éireann, we wish to advise you that the proposed building near/under can be facilitated.
